

1. Detailed description of goods and/or services

DELPHIS SOLUTIONS T/A IDIBI FIREARMS is a business in the FIREARM, AMMUNITION AND OUTDOOR industry that SELLS OUTDOOR GOODS TO THE GENERAL PUBLIC .

2. Delivery policy

Orders will only be processed once the funds reflect in our bank account.

The processing of your order may take up to 1 (one) to 4(four) business days before it is ready for pick-up in store.

The delivering of your order may take up to 5 (five) to 7(seven) business days.

Please note that some products/items will have to be transferred from other store branches,

manufacturers and/or distributing agents. Should this be the case, additional working days will be

required to complete the processing of your order.

Our delivery service only operates from Mondays to Fridays.

3. Export restriction

Licensed goods such as firearms sold on this website, can only be shipped to locations within the borders of South Africa via licensed firearm courier services.

Ammunition, primers and gunpowder may not be shipped but must be collected from our store.

Please note that we shall not attend to the international shipping of any items /products.

4. Return and Refunds policy

- The provision of goods and services by IDIBI is subject to availability. In cases of unavailability, IDIBI will refund the client in full within 30 days. Cancellation of orders by the client will attract a 15 % administration fee.
- We warrant that our products will be free of defects as at the time of shipping, however, our products are all subject to the manufacturer's warranties.
- Should an item <u>appear</u> to be defective/faulty within 7 (seven) days from receipt of your order, we shall collect the item and return the item to the manufacturer or its official distributing agent for assessment thereof. If the manufacturer or its official distributing agent determines that the product is indeed defective/faulty and is protected by a warranty, we shall repair and return or replace the item at our costs.
- If the product has been inspected by the manufacturer or its official distributing agent and is not regarded as defective/faulty, alternatively if the item is not protected by a warranty, the costs associated with the return of the item, which has not been repaired or replaced, will be for your account.



- If the product has been inspected by the manufacturer or its official distributing agent and is not regarded as defective/faulty, the costs associated with the return of the item (not repaired or replaced) will be for your account.
- Should an item, protected by a warranty, <u>become</u> defective/faulty after 7 (seven) days from receipt of your order, you shall return the item to us at your own costs. The item shall be inspected by the manufacturer or its official distributing agent. If the manufacturer or its official distributing agent determines that the product is indeed defective/faulty and confirms that it is protected by a warranty, we shall repair and return or replace the item at our costs.
- If the item is not protected by a warranty, the costs associated with the return of the item (not repaired or replaced) will be for your account.
- If the product has been inspected by the manufacturer or its official distributing agent and is not regarded as defective/faulty, the costs associated with the return of the item (not repaired or replaced) will be for your account.
- Should you not be entirely satisfied with the item you have received via the website, you may return the item to us, at your own costs, within 7 (seven) days from receipt of your order. The item should be returned in its original packaging, be unused and in the same, original condition it was received by you. The item shall be inspected by the Store Owner to determine whether the item was returned in its original condition and packaging. As there is no general right of return, the return will be accepted, only if the Store Manager is satisfied with the status of the item and packaging, and Idibi Firearms shall refund the purchase price of the item, less a 15% restocking/handling fee.
- Purchases which have been made in store, and where you have had the opportunity to examine the item before purchasing same, shall not have a general right of return. Each matter will be assessed based on its own merits.

"Change-of-heart" returns shall not be accepted.

Due to the sensitive nature thereof, items such as Ammunition, Powders and Primers are not refundable.

Gift Cards cannot be exchanged for cash, or be refunded.

5. Customer Privacy policy
